 - (i) The Bidder shall furnish documentary evidence to demonstrate that it has successfully completed three (3) contracts for similar goods as required under that lot over the last 5 (five) years and such contracts had the value greater than 50% of the value of the Bid.
 - (ii) The Bidder is required to submit with his bid, documentary evidence to demonstrate that after sales service for maintenance is already set up and available in Myanmar, or will be set up if contract is awarded to the Bidder.
 - (iii) The manufacturer of the offered goods must have minimum 10 (ten) years manufacturing experience in similar goods.
 - (iv) Meet turnover requirements as follows:

Lot 1-USD 600,000

Lot 2-USD 300,000

Lot 3-USD 500,000

Lot 4-USD 200.000

For combined award of several lots, the aggregate experience in value and turnover will be applied.
