The Union Supplementary Appropriation Law, 2018-2019 Financial Year (The Pyidaungsu Hluttaw Law No. 18, 2019) The 2nd Waxing Day of Nayon, 1381 M.E.

(4 June, 2019)

The Pyidaungsu Hluttaw hereby enacts this Law.

Chapter I

Title and Period of Effectiveness

- 1 This Law shall be called the Union Supplementary Appropriation Law, (a) 2018-2019 Financial Year.
 - This Law shall have effect for the 2018-2019 financial year. (b)

Chapter II

Sanctioned Allotment and Administration of Supplementary Expenditures

- 2. The respective persons who have been assigned responsibility for expenditures (a) sanctioned in Schedules (1), (2), (3), (4), (5), (6), (7) and (8) in respect of the Pyidaungsu Hluttaw, the Supreme Court of the Union, the Union Election Commission, the Attorney General of the Union, the Auditor General of the Union, the Union Civil Services Board, the Union Ministries and Departments, the State-owned Economic Organizations, the State-owned Economic Organizations which operate outside the Union Budget Fund, the Cantonment Municipalities, the Nay Pyi Taw Council, the Nay Pyi Taw Development Committee and the Central Bank of Myanmar may incur the relevant expenditures shown in appendices.
 - (b) Appropriation sanctioned in sub-section (a) shall be deemed to be supplementary expenditure in addition to the appropriation sanctioned under the Union Budget Law, 2018-2019.
- 3. The respective persons who have been assigned responsibility under section 2 (a) may delegate the respective officials subordinate to them to administer the expenditures for which they are responsible.

(b) In administering the expenditures, the respective persons shall carry out in conformity with the provisions of this law, the Union Budget Law, 2018-2019, relevant laws, rules, regulations, bye-laws, notifications, orders, directives and procedures.

Chapter III

Taking Loans

4. The appropriation of five hundred thousand million kyats is further estimated in addition to the total amount of loans actually received after the execution of loan agreements mentioned in section 12 of the Union Budget Law, 2018-2019.
